

# Westfield Primary Community School Website Use Privacy Notice

This privacy notice has been written to inform you about how Westfield Primary Community School processes your personal data when you visit our website, and in particular our use of cookies and web analytics.

#### Who are we?

Westfield Primary Community School is a data controller as defined by the UK GDPR. This means that we determine the purposes for which your personal data is processed and the manner of the processing. We will only collect and use your personal data in ways that are compliant with data protection legislation.

The school has appointed Veritau Ltd as its Data Protection Officer (DPO). The role of the DPO is to monitor our compliance with the UK GDPR and the Data Protection Act 2018 and advise on data protection issues. ### Web analytics

Web analytics is the collection and analysis of the data generated when people visit and use a website. This helps the website owner know such things as the number of visitors to various parts of the website, the time they spend on the website and if they return to the website. Various tools are used to produce web analytics, such as Google Analytics, which uses a set of cookies to collect data.

This website uses the following web analytics:

Many visitors to this domain do not have a user account and are known as anonymous visitors. We know very little about anonymous visitors, least of all, any information which could be used to identify them in practical terms. One exception to this general statement about anonymous visitors, would be if one chooses to contact us via the website's contact form. In this case we will ask their name and email address, so that we can reply to them, and our admin staff will also see the content of any message that they send. Such messages may be also be stored in our systems or printed so we have a paper record.

Visitors that do have an account are known as registered users. For these individuals, at the very least, we will know their user name and email address. We will also know of any other personal information provided voluntarily as part of their initial registration or afterwards. We do not share this information with any third party.

Whether just browsing this domain or submitting information via a form, all data is transmitted over a secure, encrypted connection. This is the same level of security that you would expect when shopping online or dealing with your bank.

## What are cookies?

A cookie is a small file of text that may be saved on the memory or storage of your electronic device (computer, phone, or tablet etc) when you visit a website. Cookies are used to improve the way the website works and can be used to remember the information you've provided so that you don't have to re-enter it whenever you visit a new page.

Two types of cookies are typically used:

**Session cookies** – these are temporary and are removed when you close your browser or leave a website. These are used to remember visitors as they move from page to page on a website and are typically used to store your basket when using online shopping.

**Persistent cookies** – these remain on your device for much longer, even after you close the browser or restart the device. They remain until you remove them or they expire, which can be up to 12 months. They are typically used to store information such as your name, language preferences or login information.

### What do we use cookies for?

We use cookies so that:

- We can distinguish you from other users of our website and provide a good experience.
- We can remember the information you've provided us with while on our website, so you don't have to keep re-entering the information whenever you visit a new page.
- We can look at how you use our website so that we can improve it for other users.

We do not use cookies to:

- Monitor your usage of other websites (privacy intrusive cookies).
- Collect any personal information about you (without your express permission).
- Collect any sensitive information.

- Pass data to any advertising networks.
- Pass personal data to third parties.

# **Consent for cookies**

When you first visit our website using a new browser we will provide you with a cookies permission banner, seeking your consent to the use of certain cookies.

Not all cookies require consent. Those which are required for the operation of the website, known as 'strictly necessary' cookies do not require consent. Without these cookies the website cannot work as designed.

Other types of cookies do require consent. These include:

- Functionality cookies, which are used to improve the usability of the website; Analytical or performance cookies, which are used to help us improve the website; and
- Advertising or marketing cookies, which are used to target advertising on a website.

You can change your cookie preferences at any time through our cookie banner, but please be aware that opting out of cookies may affect your user experience on our website.

## What is our lawful basis for processing your information?

Under the UK GDPR, it is essential to have a lawful basis when processing personal information. We normally rely on the following lawful bases:

- Article 6(1)(a) consent
- Article 6(1)(f) legitimate interest

We only rely on legitimate interests when we are using your data in ways you would reasonably expect.

- to request that your personal data is erased where there is no compelling reason for its continued processing.
- to request that the processing of your personal data is restricted.
- to object to your personal data being processed.
